I. <u>Call to Order</u>

Freda Eisenberg called the meeting to order at 8:07 AM with quorum.

## II. <u>Welcome New Board Member</u>

The Board welcomed new member John Konefal, who is replacing Heinrich Strauch.

#### III. <u>Approval of Minutes</u>

#### VI. <u>Resolutions for Authorized Signatory</u>

Resolutions read, entitled "Resolution Authorizing Signatory for Emerald Springs Water Company Board Checking Account with Jeff Bank" and "Resolution Authorizing Signatory for Emerald Corporate Center Economic Development Board Checking Account with Jeff Bank", moved by Baez, seconded by Sorensen, passed unanimously.

#### VII. <u>Westage Inquiry</u>

Eisenberg reported that a company called Westage has expressed interest to the realtor, Keller Williams, in Site 1 at the Corporate Park for a medical building. Eisenberg said that representatives from Westage had met with Planning and Town of Thompson. Eisenberg also reported that Crawford & Associates, who completed the original full set of plans that were submitted to and approved by the Town of Thompson, was contacted and still retained records from the project. Donna Verna, the engineer, was given clearance to share any documentation they had with Westage. The group brainstormed ways to address any of Westage's concerns.

## VIII. <u>Corporate Park Property</u>

Skoda, Chairman of the Architectural Review Board, reported that the Architectural Review Board met and reviewed conceptual renderings prepared by Keystone and gives approval to the design and those similar.

The board discussed moving forward with the Site Plan Review process and preparing an application for the Town of Thompson Planning Board to facilitate advanced approvals. Sorensen reported that the SEQR should still be valid and that extra stormwater features were in the original design. The group decided that getting these approvals would be the best way to make the park a shovel-ready site.

The board also discussed the possibility of placing a cell tower on the site, which could provide income to ECC and be a better site. Eisenberg agreed to contact Verizon on placement.

#### IX. <u>Water Company</u>

Eisenberg reported that Thompson had returned a revised agreement, which still asked ECC EDC to subsidize the new water district for 7 years after acquisition, regardless of the financial status. It also stated that ECC would pay any fees associated with a map plan report and publication fees, an estimated cost of \$6,500.

After discussion, the board agreed to retain Richard Stoloff as counsel to determine if ECC EDC would be able to subsidize a public entity, and to negotiate the agreement with the following points:

- ECC will not pay for the formation of a new water district.
- Any subsidy offered will be proportional to a loss of the new water district, at a maximum funding of \$20,000/year.
- The Town of Thompson will maintain water rates at or below market rate.

## X. Apollo Phase II

Eisenberg reported that the County is waiting on a determination from the CFA application for the Apollo back site for soft costs associated with development. The board was hopeful for a positive response.

## XI. <u>Next Meeting</u>

The next board meeting will be held on Tuesday, November 12 at 8 AM in the Planning Office. The Audit and Governance Committees will meet after the regular meeting.

## XII. Adjournment

On a motion made by Baez, seconded by Skoda, the meeting was adjourned at 8:53 AM.
