#### IV. **Yearly Housekeeping**

Meeting Schedule. Bimonthly meeting schedule was adopted, moved by Konefal and seconded by Skoda.

Appointments. The board agreed to re-appoint Sorensen and Konefal to 2-year terms, moved by Eisenberg and seconded by Weinstein.

New Member. Eisenberg reported that there is still an open board seat left by Baez's intent to step down. Skoda brought up his suggestion of appointing Karen Ellsweig, and the group agreed that Eisenberg would reach out to her and determine interest.

**2021 Officers.** The board agreed to re-appoint the 2020 officers to their positions, while replacing Baez with Konefal. Moved by Skoda, seconded by Weinstein. The officers are as follows:

#### V. **Recent Activity**

**Telecommunications Tower**. Potosek reported that the environmental paperwork is almost completed, and that there is a bid out for the foundation of the tower. The County expects the tower should be erected this summer and the projected completed by fall. Eisenberg reported that she would follow up with the County Attorney on the transfer of title.

Parcel Marketing & Disposition. Eisenberg noted that the Keller Williams contract had lapsed for marketing, but KW was still interested in renewing it. There was an inquiry about the possibility of solar panels on the property, but that is not a permitted use. Skoda mentioned that the site isn't large enough or graded appropriately for the scale of solar projects coming to the County recently. Skoda clarified with Sorensen that the installation of the tower would not have interference with any potential building per the sketch plan. The group agreed to re-issue an RFP for real estate agents.

Water Company Status. Potosek reported that members of the legislature had met with the Town of Thompson to discuss the water company. In those discussions, it was agreed that the County would not be subsidizing transfer and operation for Thompson. The County would like to be paid for the acquisition of the water company. Skoda mentioned that a transfer would save the County the funds it costs to operate the facility each year. Potosek also reported that the County is no longer interested in operating the water company as a county water district, as it would be very difficult to set up legally.

#### VI. **Public Comment**

Eisenberg noted that no members of the public had joined the meeting.

#### VII. **Conclusions and Next Steps**

The group agreed to meet by Zoom for the May meeting. Motion by Eisenberg, seconded by Weinstein, to adjourn. Passed unanimously at 8:23am.
