ACTIVITY REPORT – MAY 2015
COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY

April 29, 2015

The IDA held its regular meeting on April 13, 2015. At that meeting the Board approved a request from Deb El Food Products for IDA assistance. The business needs to expand, purchase new coolers, freezers and other equipment, and plans to hire more employees. The Board also approved installment payments of the 2015 PILOT and lease obligations for Poley Paving Corporation.

During that meeting the Board discussed and approved applications for USDA Rural Business Development Grant funds. The Sullivan County Funding Corporation will share in the cost of paying the Hudson Valley Agribusiness Development Corporation and its consultant grant writers to develop grant applications. Additionally, Board Member Ms. Roig and Stephen Stuart of Sullivan Alliance for Sustainable Development gave a presentation on “Energy Opportunities for Sullivan County Businesses.” Ms. Flad updated the Board on the status of the Rural Microentrepreneur Assistance Program. USDA’s deadline for use of the loan and grant funds is in May.

The IDA received an application from Rock Meadow Partners for a project to renovate and utilize the vacant Narrowsburg School Building. A public hearing on the project occurred on April 30, 2015, in Narrowsburg. The application is for a Master Developer proposal with tenants being added later with further review.

The IDA received an application from Catskill Stills, LTD, for an expansion at their facility on Route 17B in Bethel. The expansion will include a new storage building for barrels and a new production line behind their existing distillery building.

The construction of the building shell of the Red Meat Facility in Liberty is substantially complete and building equipment is being purchased. It is expected that the operator request for proposals will be distributed in the coming month. Staff continues to monitor all grant requirements and track the overall project budget.

With respect to other agricultural economic development programs and initiatives, IDA staff has assisted in the development of the Sullivan County Farmland Protection Plan and serves on the new Agricultural Task Force, which will implement the plan. Staff also assists the Sullivan County Planning Division in its development of a local dairy processing facility.

The Agency worked with several small businesses regarding IDA and Sullivan County Funding Corp (SCFC) loan programs.

Report to Legislature May 2015

A. General Operations

1)

- There has now been a steady flow of inquiries and presentations relative to a variety of potential projects interested in coming to Sullivan County and positioning to take advantage of the Adelaar/Montreign momentum. Additional, hotels, retail alternatives, workforce housing projects and other recreational/entertainment development prospects are now analyzing specific locations for future projects. While it is steady at this time we anticipate rapid acceleration of this trend transferring into real construction activity once the Montreign project begins to go vertical.
- I was invited along with a SCVA and other stakeholders, to attend the Camelback Ski & Water Park Resort destination soft opening in the Poconos. The facility was very impressive and the water park was very expansive and well done. As the group that built the new facilities at Camelback will also be building the facility at Adelaar, it presented an extraordinary economic development project in terms of investment, jobs and future commerce opportunities for Adelaar and Sullivan County.
- I attended a meeting coordinated by Renaissance to address improving aesthetic, economic, and general business climate issues in Liberty. As one of our larger urban centers Liberty was very involved in and looking forward to one of the casino licenses for their town. Now community leaders and interested stakeholders are looking to take on some of its longstanding issues and begin steps to help the community turn things around. If successful we hope to replicate throughout the county.

2) **Internal/External Marketing –**

- The Sullivan United economic development team will be hosting a breakfast on June 24 at 8:30 located in Bernie's. The breakfast will feature a Pattern for Progress presentation providing a updated analysis if Sullivan County in terms of land use, demographic trends, growth patterns and future outlook among other critical indices to help our local agencies, businesses and resident understand not only the changing dynamics of the Hudson Valley, but also those that are here close to home in Sullivan County. With the recent announcement of our Resort Destination projects a glimpse of where we are and what we need to focus on is a most important exercise. Announcements will be forth coming via a variety of media channels.

3) **Community Outreach –** Board of Supervisors meeting, School Superintendents meeting, Sullivan County Airport Commission, Narrowsburg School, Village of Monticello, HVEDC, SC Chamber.

B. Project Updates

a. Corporate Attraction

- We have responded to an additional inquiry interested in developing a Hotel featuring an indoor water park. The project proponents claim to have site control and are completing due diligence at this time. Update: We have met with the proposed development group. We teamed up with the SCVA to tour key properties in Sullivan County to give the prospects a taste of what the current and future development landscape holds for future developers. A letter of intent has been drafted.
- We have responded to a lead for a green plastic to energy bio fuel producer. The company seeks a location for a 100,000k facility that will convert # 3, 4, 5 plastics to a bio fuel. After a conference call with the principals we are now putting together needed items including site data for their consideration. The outreach was conducted by WEDA. TBD
- We have submitted a proposal in response to an Italian firm looking to build a food processing facility that produce high end cured hams and specialty meat products. The company is seeking to construct a 50,000 facility in the US and has visited some Sullivan county sites already. Update: The firm will be touring additional sites in Sullivan County on May 12.
- We have submitted a site proximate to SCCC for consideration of a cheese processing facility. The firm would be eligible for Start Up as it falls within the 1 mile threshold. The site has access to water and sewer which is a must. The project falls within SCCC's world nutritional arts focus. Update. The engineer working for the client has responded favorably to the location thus far. TBD
- We have submitted our proposal and letter of interest to site selectors seeking a location for a Silicon Valley based firm that produces electronics for appliances. SCCC and Start UP NY are a good fit for this prospect. The facility would be small to mid-sized and could take advantage of the smart labs and analytics efforts the college is undertaking at this time. TBD.
- We are in discussions with a New York City chef interested in establishing a chocolate factory in Sullivan County. He has been touring several hamlets as part of his due diligence. The gentleman has ties to the area. Update1: Two areas have been toured, Livingston Manor and Hurleyville. A business plan is being developed at this time based on where the prospect will ultimately choose as a location. Update: The principal has met with SCIDA, Planning and SCP. We are waiting for a determination from him to move forward. Update2: A CFA application is underway.

b. Small Business/Entrepreneurial Development

- The Partnership Revolving Loan Committee has approved financing for Sal & Pepper located on Broadway in Monticello and Liberty Collision, in Liberty, NY.
- IWW funds available \$99,000 There are currently 10 loans within this program:
- SI funds available \$ 18,000 There are currently 11 loans with this program:

c. Business Expansion

Automotive body shop will expand to a fully owned facility from existing leased space. The move will create 2-5 additional net new jobs. SCP has approved financing.

d. Shovel Ready Sites

An existing owner of a key development site along the old route 17 corridor is in the process of updating engineering, addressing site plan changes, and finalizing "Shovel Ready" status on the property. As an owner of several key parcels in the Thompson/Liberty area the principal is looking to move ahead in the areas of workforce development retail and Light Industrial applications, all stemming from the Casino licensing decision. Update: Site owners have engaged new professionals to review existing work and fully complete the approvals process. They are completing redesign for approvals process at this time.

e. Cluster Development

Due to high interest in the hospitality area we are analyzing sub-clusters of this industry sector for internal/external solicitation and investment opportunities.

- ❖ The Workforce Partners Group met with the casino resort construction project manager, Kyle Tuttle from LP Ciminelli on April 14. There are ongoing meetings with education and training on creating a training structure for the casino and for hospitality as an industry.

There is a meeting being scheduled with the workforce development directors from the Catskill and Hudson Valley regions.

- ❖ An RBDG application has been submitted to fund a labor availability and casino impact study.
- ❖ Sullivan Renaissance Youth Internship program starts this month. The program will provide 18 county youth the opportunity to participate in a summer long paid work experience earning \$10/hour. Orientation is scheduled for May and the majority of work with area Renaissance projects will begin in June.

- ❖ Planning is underway for the Summer Youth Employment Program which will run from July 6 through August 14. There is a waiting list of youth and applications are being accepted. Outreach is underway for worksites.
- ❖ Spoke on workforce issues as part of a panel on April 15 as part of the Green tourism Conference. The conference was held at Woodloch Pines in Hawley PA and brought organizations and businesses from both states together.
- ❖ Provided training on hiring employees to the participants of the Planning Departments' Microenterprise Assistance Program (MAP).
- ❖ Provided information on workforce business services to the Sullivan Chamber of Commerce on April 23 as part of a group that included the Planning Dept. and the Workforce Development Institute.
