NANCY BUCK, being duly sworn, deposes and says:

1. I am the RPTL Article 11 Enforcing Officer and Treasurer for the County of Sullivan, State of New York. A public auction was held in and for the County of Sullivan on September 6, 2024 and September 7, 2024 and annexed hereto as Exhibit “1” is the Final Financial Report of Absolute Auctions & Realty, Inc., setting forth the purchase price for each parcel sold at said public auction. All of the parcels in question were foreclosed upon by the County of Sullivan by an action In Rem for the tax year 2021, pursuant to Article Eleven of the Real Property Tax Law. The public auction [defined in RPTL §1195(2)] was performed by Absolute Auctions & Realty, Inc., in accordance with §231 of the NYS Real Property Actions and Proceedings Law and Absolute Auctions & Realty Inc., followed all requirements set forth therein.
2. Several parcels did not realize a surplus in auction sale proceeds and a detailed list of those parcels and their tax delinquency is annexed hereto as Exhibit “2”.

3. The parcels noted on the attached Exhibit "2" were all sold at the public auction, but the delinquent taxes, interest and fees exceeded the bid price.
4. In addition to the parcels contained on Exhibit "2", there were five additional parcels which the County foreclosed upon but which did not receive bids or the bid was rejected and the reasons for each are set forth below:

A. Bethel 46.-13-7

This parcel is a 30' x 250' undeveloped road which was created by the filing of a subdivision map. The dedication of the parcel to the County or Town should have been done by the applicant at the time of the filing of the subdivision, but was never accomplished. This parcel was offered to adjoining owners, but no adjoining owners were interested in purchasing the same. There was a successful bidder for the parcel in question, but after discussion with the bidder, it was clear that they did not realize they bought an unusable portion of a road. The bid was rejected and all funds were returned to the bidder. This parcel has since been removed from the County Tax Rolls pursuant to Real Property Tax Law §1138. At the time of the auction, the County was owed \$378.29 in delinquent taxes, penalties and interest.

B. Bethel 55.A-1-76

This parcel is a 4 acre landlocked parcel of land which was created by the filing of a subdivision/lot improvement map in 2006. Since that time, the owner of this parcel has been "unknown" and the taxes have been paid by a third party (non-owner). That third party has since stopped voluntarily paying taxes on this parcel. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so. There was a successful bidder for the parcel in question, but after discussion with the bidder, it was clear that they did not realize they bought a landlocked parcel of land. The bid was rejected and all funds were returned to the bidder. This parcel has since been removed from the County Tax Rolls pursuant to Real Property Tax Law §1138. At the time of the auction, the County was owed \$548.93 in delinquent taxes, penalties and interest.

C. Fallsburg 51.-2-22

This parcel is a small 20' x 233.07' strip of land/road. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so. This parcel received no bids at the public auction. This parcel has since been removed from the County Tax Rolls pursuant to Real Property Tax Law §1138. At the time of the auction, the County was owed \$382.80 in delinquent taxes, penalties and interest.


D. Forestburgh 30.-2-4.1

This parcel is a small 10' x 490' (0.11 acre) strip of land/road created in 1938. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so. This parcel received no bids at the public auction. This parcel has since been removed from the County Tax Rolls pursuant to Real Property Tax Law §1138. At the time of the auction, the County was owed \$735.17 in delinquent taxes, penalties and interest.

E. Lumberland 5.-11-9

This parcel is a 100.8' x 119' landlocked parcel of land which was created by the filing of a subdivision/lot improvement map in 1960. The parcel is adjacent to several parcels and all owners have been afforded an opportunity to purchase this lot, but none have offered to do so. This parcel received no bids at the public auction. This parcel has since been removed from the County Tax Rolls pursuant to Real Property Tax Law §1138. At the time of the auction, the County was owed \$436.56 in delinquent taxes, penalties and interest.

5. For the reasons set forth above, I respectfully request that the Court confirm that the parcels noted above have no surplus funds available pursuant to the provisions of the NYS Real Property Tax Law relating to the distribution of surplus.
