## HEAP PROCESS & PROCEDURE 2020-2021

The program officially starts on November 2, 2020! You can't get an application before that date but here is some information that will help you get your benefit this year. Don't plan to come back to DFS for your application as our lobby is currently closed! We have become a processing center – plan to see one of our Community Partners listed below or call DFS at 845-807-0142 for assistance with your application.

- 1. Apply online at: <u>www.mybenefits.ny.gov</u> on or after November 2, 2020.
- 2. Visit: <u>www.mybenefits.ny.gov</u> and click on HEAP under Assistance Programs. This will take you to a link for a paper application that you can print, fill out, and drop off at a Community Partner listed below on or after November 2, 2020. Your application can also be mailed back to us at DFS.
- 3. If you are a NEW APPLICANT, you will need to fill out an application online. You can also request that an application be mailed to you. You may also apply in person at a Community Partner location. If you do not apply in person you MUST have a phone interview. You will need to provide a valid social security number for all household members, proof of residence and earned and unearned income for all household members. If you are a RETURNING APPLICANT (had HEAP last year or within the past 3 years) you will need to complete a HEAP application online or pick one up at one of the Community Partners listed below. You must provide current earned income for the entire household plus report all current household members. You will not be required to have an interview.
