#### Budget

- If continue as we are we will end the year with at \$275,980 shortfall
- Personnel & Finance Committee have been having extended discussions on the situation
  - Resolution: P&F directs the Executive Director to cut \$275,000 from the budget and or raise the equivalent by June 7<sup>th</sup>.
- Federal retro-active cuts will not be bringing in expected income
- Look at program history (attendance, profit, etc.)
- This cut will not fall equally across the board
- Cant cut staff that bring in funding (grant paid staff)
- Alternative merge with Delaware, Orange or Ulster and become a regional office
  - This would be a last choice if we lose more funding and cannot bring in any alternate funding source.
- Motion made by Glenn, seconded by Pam to set a plan in motion to cut \$275,000 from the budget or raise the equivalent by June 7<sup>th</sup>. Seconded by Pam, all in favor, passed.
- Greg will meet with the staff in the morning and let them know this motion was made by the Board.

## Fundraising Committee Report

- Friends of Extension will meet on June 4<sup>th</sup>
- Five committees have been set
- Goal is to raise \$200,000 for building and programs
- July 12<sup>th</sup> will be the kick-off
- June 11<sup>th</sup> is the next Friends of Extension Meeting
