Legislative Report – Kitty

- Still working on redistricting Legislative Districts
- Discussions ongoing with no changes on the shared position with CCE & County Planning
- No new decisions on Jail
- Main issues

 - Governor has allotted money to the flood victims in Sullivan County

Search Committee

- 25 applicants, 10 phone interviews, invited 4 candidates to interview, one rescinded
- Search committee voted on Colleen Monahan as the first choice candidate and would like the board to approve the appointment
 - She is currently the program coordinator for the Orange County Youth Bureau extensive grant experience
- Motion to accept made by Sonja, seconded by Kitty, all in favor, no opposed. Approved
- Charlie thanked the Board for stepping up to the plate and taking the reins over the past several years
- Colleen will start October 6th and then will be at ED meetings and boot camp on the 7th & 8th

Presidents Report – Joan

- Building Update
 - Phil and Jerry have been helping raise the funds to make the improvements and working with the trades people and suppliers
 - If all continues to go well, we will be moving forward with the new roof and insulation to complete by end of October

- o A donor has come forward and may be willing to match the money we raise
- John has done a wonderful job patching the HVAC system and hopefully it will get us through another winter
- Board and PAC Recruitment and Procedure to replace outgoing members
 - o Joan has completed her 6 years
 - o Several members have the option to run again for another three year term
 - Will be advertised in the newsletter
 - o Applications for Board and Program Committee are available (distributed)
 - Vote will be at the December Annual Meeting

Directors Report - Pat Claiborne

- Interim ED in SC has been very rewarding and she has enjoyed it very much. She is totally impressed by the programming that is being done by the staff, they have made her look good to the legislators.
- ESNY is ending in its current situation on Sept 30th. We will be having ESNY in Sullivan County, but the whole program will look different. We will be housing a Resource Educator here that will be hired and supervised by Orange County
- Govt Services presentations have been going very well. This past meeting the EaT Kitchen slide show was shown at request of Cora Edwards
 - Karin from SCCC was impressed and wanted to meet with Pat the next day to collaborate on a project they are working on
- 2015 Budget was presented to the County level funded and then Pat met with the County Manager to discuss the budget
- Shared Ag Position –discussions going on around that position and the expectations of both CCE and the County
- Meetings continue to go on with other agencies, staff and the program committee

Personnel & Finance Committee Report – Glenn

- Financial Statements
 - o June Statement of Financial Position and Operational Statement
 - 6 month ending we are level spending as much as we are bringing in
 - July Statement of Financial Position and Operation Statement
 - July statement has increased savings due to county appropriation
 - July we don't pay a Cornell bill we receive a double bill in August
- Line of Credit
 - We currently have a line of credit against our CD for approx. \$73,000
 - We would like to go to a bank and secure a line of credit against the building (voted on by P&F Committee)
 - Need to have restrictions on what it is used for and how we are going to pay it back
 - Will need to signatures on withdrawing from this line
 - Will need to set a limit on what we want to obtain and then bring this back to the committee
 - Would like a vote on going forward to secure this line of credit Motion to allow new ED to work on securing a line of credit at the best rate possible and bring back the information to the Board made by Dawn, seconded by Donna, all in favor, approved
- Personnel
 - o ESNY current staff have received their separation letters
 - Working on EaT Kitchen position
 - Rest of staff are in line

Program Committee Report

- Susan Dollard gave an in-depth review of the Master Gardener program
- 4-H is serving over 300 youth in the County
 - o Shooting Sports will be adding many other youth to the program
 - o Fair specifically the dairy program is a concern of some community members
 - Need to have a discussion on how to get more volunteers to meet some of these requests
 - o Need to defer fair to 4-H strategy committee at this time
- Newsletter was discussed cost, on-line vs. printed copy
- Committee is spending 90% of the time listening to staff reports is this the best use of the committees time
- Need to have a guide from the Board on what they want this committee to have as goals and guidelines

Fundraising Committee Report - Glenn

- Barn Dance was cancelled due to poor ticket sales date was moved
- October 18th Trail Walk to include youth to walk with education November 9th Gala noon 4 pm \$75 with an auction
- - Invitations going out October 1st
 - o Board members need to sell tickets
