Legislative

- Ag Farmland Protection Plan moving forward
- Planning and CCE are working together more closely
 - More focus on Ag from planning
- Governor wants to make broadband accessible to all New York residents

Presidents Report

- Feedback Form is being implemented across all programs (except 4-H/Youth)– will be completed by program participants
- Please help out with the Fund Development Committee
 - Fund Development Plan will be shared
- Chain of command Board members need to go directly to the ED with concerns and issues not to staff members

Program Committee Report

- Met in Feb
- Exploring ways to serve the Latino youth population (highest growing population in Sullivan County)
 - $\circ~$ We can share some basic CCE info in Spanish but do not have bilingual program staff
 - Make our office a safe place for people to come
 - Look for grants to pay for a translator or liaison
- Kitchen grants were discussed
 - NY Farm Viability hopefully we should hear by the end of March
 - One for Kitchen Management 30 hours per week
 - One for Livestock Production Management
- 4-H Shooting Sports program is growing

- Outreach to young farmers was discussed brochures at local ag stores for upcoming programs etc.
- Do fewer things but do them well quality vs. quantity
- Plan of work was shared, as well as the strategic plan

ED Report

- Attended a seminar in Brooklyn on the Hasidic Communities and programming with them
- Cyber Insurance
 - \circ To protect CCE but would provide fraud monitoring in a data compromised breech
- Building Update
 - We received a check for \$50,000 today for the capital improvement
 - \$50,000 grant from Aileen Gunther
 - \$100,000 from a private donor
 - \$36,000 from past fundraising is in an account for capital improvements
 - \circ Should start on the roof in the next 3-4 weeks (strip shingles, add insulation and tin the roof) –
 - Once roof and HVAC projects are complete there is a projected 40% energy savings
- EaT Kitchen
 - LDC is on hiatus they currently own the kitchen appliances, but will be turned over to CCE
- SWCD Proposal
 - Lease outdoor space to raise some plants
- Grants
 - 2 USDA have been submitted
 - 1 to Youth Bureau
 - 1 due April first
- Strategic Plan
 - Four main strategies community engagement, core programming, regional networks, resource stability
 - Strategic plan document should have performance measures developed over time
 - Motion to adopt this as our starting point made by Glenn, seconded by Steve, all in favor
- Database
 - Adopting CIVICRM open source database
 - Reaching out to three vendors that are contributors an helped design the program
 - Anywhere from \$10,000-20,000 project (one-time fee)
 - Volunteer, donor, automatic enrollment, registration, connecting families etc.
- Partnering with Planning Dept and CARDI to bring planning techniques to the County to reestablish our County as a resort community

- Our liabilities decreased by over \$20,000 by capping and carryover of vacation time

 - Significant fundraising will be needed to meet our expenses
