- D. Grady reported on his upcoming meetings

#### **Buildings & Grounds:**

I. Rieger reported that the renovations of the Kaplan Family Hospice Residence are moving ahead. I. Rieger noted we are still waiting for the Greek Church response to our offer.

# **Compliance:**

F. Phillips reported that a contract has been signed with SHP for Hospice's family satisfaction surveys.

#### Personnel:

F. Phillips reported that Hospice had a personnel turnover of 35 out of 135, 28 were volunteers and 7 were employees. Currently Hospice has 17 posted positions.

#### **Fundraising/Marketing:**

- T. Sullivan reported on the digital/e-mail blast campaign, it increased on line donations by 62% compared to last December 2013. The Facebook Campaign reached over 30,600 viewers and FB page received 100 new "Likes" during the month of December. The Hospice website received over 70% new views in the month of December. Niki Jones Agency has been contracted and marketing campaigns are being created along with revisions for an updated website.
- T. Sullivan reported that the original Circle of Life Campaign that began in 2007 has ended with all but one pledge met in 2014. The Circle of Life Giving Society will be launched in 2015. This society will be specifically for Donations of \$1,000 per year designated to the Circle of Life. Only those who donate in the year will be listed as a member. The goal is to keep this as a continuous giving society and. COL Society members will be invited to a special event every year and other perks. The Society will launch by mail/email and digital by end of first quarter. All Founding Members of the Original COL Campaign will stay as FOUNDING MEMBERS of the society. To date we have approximately 4 donors who continue to give \$1,000 to COL yearly. These donors will now be a part of the society with others to be added.
